

# Person With a Disability (PWAD) 2023-24 – Becoming Para Ready

Using the principles shared during the **Be Para Ready Workshops** in the spring – what is your club/division proposing to undertake to become more para ready, and shift your inclusive and Para-Nordic programming?

Nordiq Canada has a **total of \$30,000** to support grassroot and Gold Medal Pathway (GMP) Para Nordic initiatives across Canada – and will support up to a maximum of 50% of a proposed initiative.

### APPLICATION PROCESS FOR FUNDING ASSISTANCE

**Submit in** <u>one single PDF document</u> the following information. Your club/division's application should use the following headings and, in the order, listed below. (Maximum 10 pages; point form recommended)

Please outline your proposed projects and initiatives in relation to the **10** Ps, your expected outcomes and how the funding will be used to create meaningful change.

For clubs applying for PWAD funding, a letter of support from your division is strongly recommended.

## A. COVER LETTER

i. A one-page letter **stating the amount requested (in bold) up to a maximum of \$7,500** from the PWAD grant and a brief overview of the club/division's needs and how those funds would be utilized including the anticipated impacts.

#### **B. PWAD APPLICATION FORM:**

i. Complete APPENDIX A.

#### **C. ORGANIZATION**

The club/division must be able to demonstrate organizational effectiveness and a healthy and vibrant development system based on the Para Nordic LTAD model. For each of the P's listed below, please provide the requested evidence or plan to address any gaps.

- 1. Does your club/division have a written and posted **PHILOSOPHY** regarding inclusion of people with a disability (please include a link as evidence)?
  - I. How is disability and inclusion defined within this philosophy?
  - II. How is your philosophy reflected in your programming and services?
  - III. What is your desired future state for inclusion?



- 2. Who are the **PEOPLE** leading the Para Nordic and/or inclusion initiatives at your club/in your division?
  - I. What is their experience in para sport specifically, and/or in inclusive programming?
  - II. What level of AWAD coaching will the coach(es) responsible for delivering the program have?
  - III. Has anyone involved in this project taken the Becoming Para Ready course?
  - IV. What programs exist at your club/in your division to expand your knowledge, and awareness to deliver inclusive programming?
  - V. What capacity does your club/division currently have to support and deliver inclusive programming including recreational and competitive pathway programs?
