Paralympic Winter Games Nomination Selection Criteria 2022

As per 5.5 Nordiq Canada, with the successful completed of the WPNS World Cup in Canmore, Nordiq Canada has deemed it is not necessary to hold a Trials event for PWG nomination qualification.

Selection Criteria 5.C.7: Athletes who meet, at least the minimum IPC Paralympic Games qualification criteria¹ may be nominated use a ranking system (5.C.10).

Selection Criteria 5.C.10 a-d: The ranking list will be created as follows:

- a. A single ranking list per gender will be created
- b. Only individual final finish will be counted (see definition in criteria document)
- c. Ranking will be based on the average of the athlete's best two WPNS point results, inclusive of cross-country and biathlon events, at a WPNS sanctioned competition during the qualification period.
- d. The result must be obtained in a qualifying race. A qualifying race is defined as having a depth of field- any WPNS sanctioned World Cup race with at least three (3) WPNS points ranked competitors including at least one competitor with 60 or fewer WPNS points

¹ For Para Biathlon: Be ranked and have at least one (1) race of 180 points or less on the WPBT Ranking Points List as of 14 February 2022.
